In accordance with the Law No. 6698 on the Protection of Personal Data ("Law"), the Law No. 5651 on the Regulation of Publications on the Internet and the Fight Against Crimes Committed Through These Publications, the Electronic Communications Law No. 5809 and other related legislation, we would like to inform you about the types of cookies we use on our website (www.konyakagit.com.tr), their intended use and settings, management and deletion.

Cookies are small text files that are saved on your computer, mobile phone and tablet etc. mobile device via your browser, which enables our website to work more efficiently when you visit our website, offering personalised pages that are suitable for your needs and fast.

Our website only uses a first-party session as strictly necessary for the provision of the service.

Types of Cookies

Types of cookies according to the duration of use: Session cookies are used to ensure the continuity of the session and these cookies are deleted when the user closes the browser. These are also called temporary cookies. Permanent cookies, on the other hand, are not deleted when the internet browser is closed and are automatically deleted on a certain date or after a certain period of time.

First-party and third-party cookies: First-party cookies are placed directly by the website visited by the user, i.e. the address shown in the address bar of the browser (www.konyakagit.com.tr). Third-party cookies are placed by a different domain other than the address the user visits. In this context, only first-party cookies are used on our website.

Types of cookies according to their intended use: Cookies can be used for purposes such as strictly necessary (mandatory), functional, performance, analysis, advertising / marketing according to their intended use..

<u>Mandatory Cookies:</u> Cookies that are mandatory for the correct operation of our site are used for purposes such as security and authentication. Authentication is used to ensure that existing session information is not lost..

<u>Functional Cookies:</u> These are cookies that enable the site visitors' preferences such as language, text font size, etc. to be remembered.

<u>Performance and Analysis Cookies:</u> These are cookies that help the development of our site, collect information about the use of the site by visitors, check whether the site is working properly, and are used to detect errors. Cookies that allow statistical measurement in order to analyse the behaviour of users on websites. These cookies are frequently used to improve the site, including the measurement of the effect of advertisements on the relevant people. They are used by website owners to estimate the number of unique visitors, to identify the most important search engine keywords that lead to a web page or to monitor the browsing status on the website.

Advertising/Marketing Cookies: With these cookies, it is aimed to follow the online movements of users in the internet environment, to determine their personal interests and to show advertisements to users in the internet environment for these interests.

In this context, strictly necessary cookies are used in order to provide the information society services you have explicitly requested on our website.

- Mozilla Firefox-> Options -> Privacy and Security -> History -> Change Firefox setting to Use custom settings for history -> Show cookies-> In the Search: field, type the name of the site whose cookies you want to delete-> Select the cookie(s) you want to delete -> Delete selected -> Close
- Safari -> Preferences -> Privacy -> Privacy -> Website Data -> Select one or more websites -> Delete or Delete All

Mobile

On Apple Devices;

You can clear your browsing history and cookies with "Settings -> Safari -> Delete History and Website Data" steps.

To delete cookies and keep your history, you can follow the steps "Settings -> Safari -> Advanced -> Website Data -> Delete All Website Data".

If you do not want history data to be kept while visiting sites;

You can activate private browsing by following the steps "Safari -> Site icon -> Private -> Done".

You can block cookies with the steps "Settings -> Safari -> Block All Cookies". Some sites may not work properly when you block cookies.

On Android Devices;

You can clear cookies with the "Chrome App -> Settings -> Privacy -> Clear browsing data -> Cookies, media licences and site data -> Clear Data" option.

You can allow or block cookies with the "Chrome App -> Settings -> Site Settings -> Cookies" option.

Data Owner Rights:

You have the following rights regarding your processed personal data in accordance with Article 11 of the Personal Data Protection Law No. 6698:

- To learn whether your personal data is processed by applying to our company and to request information if your personal data has been processed,
- To learn whether your personal data has been processed or not, and if processed, to request information about it,
- To learn the third parties to whom your personal data is transferred domestically or abroad,
- To request correction of your personal data in case of incomplete or incorrect processing,
- To request the deletion or destruction of your personal data within the conditions stipulated in Article 7 of the Law No. 6698 on the Protection of Personal Data,
- In the event that your personal data is deleted or destroyed for the above reasons, to request information to be given to third parties to whom they are transferred,
- Object to the occurrence of a result to your detriment by analysing your processed personal data exclusively through automated systems,
- In case you suffer damage due to unlawful processing of your personal data, to request compensation for your damage.

Your request will be finalised free of charge within thirty days at the latest. If the fulfilment of your request requires an additional cost, you may be charged a fee according to the tariff to be determined by the Personal Data Protection Board.

Pursuant to Article 11 of Law No. 6698, you can make your requests by submitting the Application Form in the Personal Data Protection menu of the website www.konyakagit.com.tr to Konya Kağıt by using one of the communication channels in the application form or by sending it to the company address by mail.
